Proving and pricing disruption claims can be incredibly challenging and complex. Furthermore, in most cases, Contractors sustain losses from disruption claims without even realising it; these latent losses are an important aspect of disruption claims.

For example, let's assume that a construction company loses 10,000 Eur on a construction activity due to a "disruptive claim event". Assuming that the project has a profit margin of 5 %, the company would have to generate an additional turnover of 210,000 Eur just to offset this loss.

A few disruptive events, like the one described above, could wipe out the project's profit. Without adequate recovery through Disruption Claims, sustained losses like this could result in companies going bankrupt.

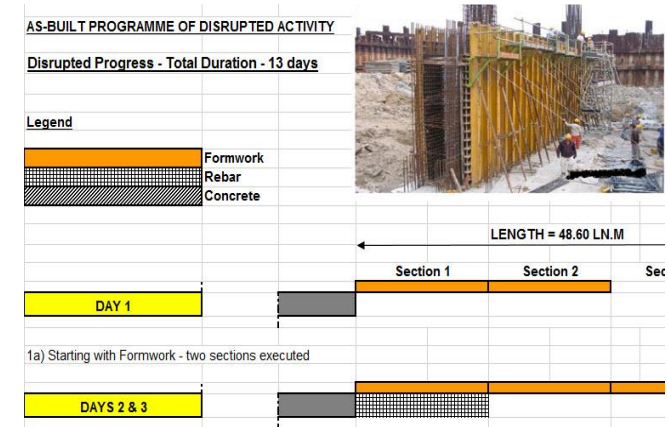
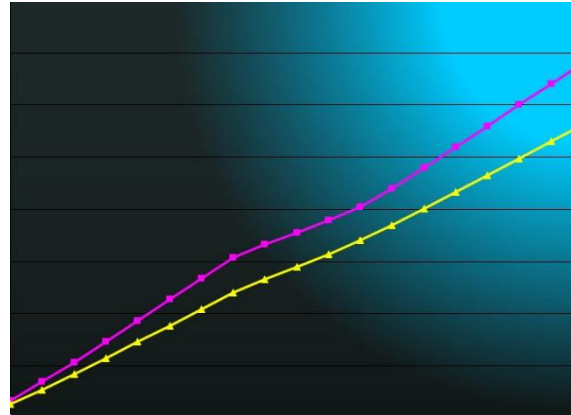
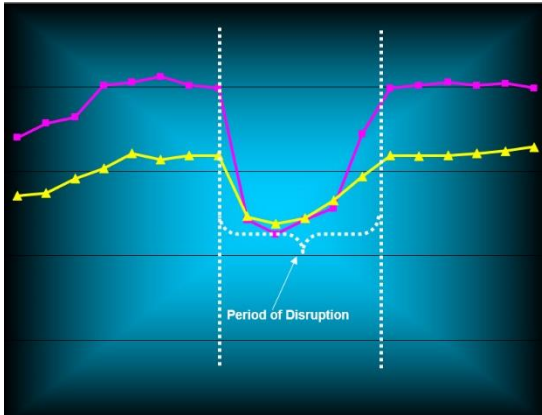
